At the outset of the meeting, the Chairman of the Academic Council, Principal Dr. Ms. S. V. Rajmanya welcomed the members of the First Academic Council of Sangameshwar College (Autonomous). The Secretary of Sangameshwar Education Society Hon. Shri Dharmraj Kadadi welcomed and felicitated the Academic Council members nominated by the Governing Body as well as by PAH Solapur University. The Principal of Sangameshwar College, Solapur Dr. Mrs. S. V. Rajmanya welcomed and felicitated the Secretary of Sangameshwar Education Society Hon. Shri Dharmraj Kadadi.

After detailed discussion on the topics in the agenda, the following resolutions were passed-

1.1 To inform about award of Autonomous Status to Sangameshwar College, Solapur by University Grants Commission and Punyashlok Ahilyadevi Holkar Solapur University, Solapur. (Review of the Autonomy Status)

Dr. S D Gothe, Member-Secretary of the Academic Council, informed the members about the benchmarks set by Sangameshwar College in the field of education and about the efforts taken to achieve the aim of 'Autonomy'. September, .2019) and that of PAH Solapur University (PAHSUS/Affiliation/2019/8487, dated 7th November, 2019). It was conveyed that the Educational Autonomy was granted for 10 years from the academic year 2019- 2020. (ANNEXURE 1)

It was *resolved* that information regarding award of Autonomous Status to Sangameshwar College, Solapur by UGC and PAH Solapur University, Solapur was unanimously confirmed and noted by all Academic Council members.

1.2 To inform nominations of University Representatives on Academic Council

According to the UGC guidelines for autonomous colleges, three members are to be nominated by the parent University for Academic Council. Accordingly, PAH Solapur University had nominated three members by its letter (PAHSUS/Affiliation/2019/470, dated 16th January, 2020). It was *resolved* that information regarding the nominations of teachers on Academic Council by the Governing Body was confirmed and noted by all Academic Council members.

2. To inform regarding Board of Studies in English, Marathi, Hindi, Kannada, Geography, Psychology, Sociology, Business Economics, Entire Economics, Political Science, History, Commerce, Management, Accountancy, B. Lib and Information Science, BJMC, Physics, Chemistry, Mathematics, Statistics, Electronic, Zoology, Botany, BBA, BCA, BSc. (ECS) (ANNEXURE 5)

The Chairman of the Academic Council, Principal Dr. Mrs. S. V. Rajmanya, informed that the Board of Studies (BOS) for various subjects was formed according to the guidelines for autonomous colleges. The Heads of various departments are to act as BOS Chairman, who is also nominated as Member of Academic Council. The Chairman put forward the proposal that these nominations be granted.

The University nominated members Dr. G. S. Kamble and Dr. Ms. Kirti Pandey said that Academic Council is an Apex Body and asked if all the members of B.O.S. are eligible according to university rules. They suggested that temporary teachers and teachers on clock hour basis (CHB) should not be appointed on B.O.S.

It was *resolved* that Board of Studies in English, Marathi, Hindi, Kannada, Geography, Psychology, Sociology, Business Economics, Entire Economics, Political Science, History, Commerce, Management, Accountancy, B.Lib and Information Science, BJMC, Physics, Chemistry, Mathematics, Statistics, Electronic, Zoology, Botany, BBA, BCA, BSc.(ECS) formed by Sangameshwar College in accordance with the UGC guidelines for autonomous colleges, were confirmed and approved by majority with corrections wherever necessary.

3. To approve course structure, curricula of First Year of various UG and PG courses and approval for Research Centres

a) To approve course structure, curricular of First Year – Various UG & PG Courses:

The Chairman of the Academic Council informed the members that the syllabi of different subjects were given consent in e-meetings of B.O.S. and by email. The departments concerned have

kept the record of these meetings. She further proposed that the course structure and the syllabi prepared by various B.O.S. be given consent. (ANNEXURE 6, 7)

Discussion:

1) Dr. Gambhir and Dr. Kirti Pandey asked the members of the committee to give information about the uniqueness of the structure of the course as well as the syllabi.

Deliberations -

- i. Dr. P. M. Dargopatil (Head of Statistics Department) informed that various B.O.S. had prepared the syllabi according to the UGC guidelines. He illustrated his point by giving the example of the syllabus from the faculty of science.
- ii. The Head of the Department of B.B.A. Ms. J. J. Kadadi (Head, BBA) informed about the changes made in the syllabus of B.B.A.
- iii. Ms. Hundekari informed about the drastic changes made in the syllabi of B. Sc (ECS), BCA, etc.
- iv. Head of the Department of Political Science Mr. R. P. Buwa gave information about the changes in the syllabus of MA (Political Science); and
- v. P.G. coordinator Dr. S. G. Sontakke, Head of Psychology Department informed about the structure of MA syllabi.

2) Principal Dr. E. U. Masumdar suggested that credit should be given to non-practical subjects in the syllabi of M. Com. He also pointed out that the structure should be changed (after defining hard and soft) and consent should be sought from the BOS concerned.

It was *resolved* that the course structure and curricula of First Year of various UG and PG courses, prepared by various BOS, according to the guidelines of UGC were approved by consensus after detailed discussion.

B) A proposal seeking permission for Research Centres at college level (ANNEXURE 8)

Discussion:

- i. Principal Dr. Kirti Pandey informed that it is necessary to have two research guides in the subject concerned.
- ii. Dr. E. U. Masumdar pointed out that in order to have a research Centre at college, it is mandatory to have the PG programme of the subject concerned at college.
- iii. It was also suggested that guidance should be sought from the University regarding the

It was *resolved* that approval for research centres at college level is subject to the rules and regulations of UGC as well as the parent University.

4. To approve curricula of various Skill Based Certificate Courses, Rules and Regulations (UG and PG)

The Chairman sought the approval of the Academic Council for 40 skill- based Certificate Courses to be run for skill development of students of various faculties. (ANNEXURE 9)

It was *resolved* that the curricula of various Skill Based Certificate Courses, Rules and Regulations prepared by BOS for the skill development of students (UG and PG) from various faculties were approved by consensus.

5. Approval of Academic Calendar for Academic Year 2020-2021

The Member- Secretary of the Academic Council Dr S. D. Gothe presented the Academic Calendar for the year 2020-21 (ANNEXURE 10)

It was *resolved* that the Academic Calendar for Academic Year 2020-21 was discussed and unanimously approved by permitting the feasible changes in teaching learning process in the situation of Covid-19 pandemic.

6. To approve Examination pattern, Examination Cell, Paper Setters, Examiners, Moderators under Autonomy.

The Chairman of the Academic Council Dr. S. V. Rajmanya put forth the proposal that the examination pattern, paper setters, examiners, the controller, nature of question paper, etc. prepared by BOS be approved by the Academic Council. (ANNEXURE 11)

Discussion:

- Dr. R. R. Yelikar expressed the opinion that autonomous colleges can change 50% of the syllabus prescribed by the University.
- Dr. G. S. Kamble said that semester exam can be conducted for 100 marks. Similarly, different new options can be provided to different subjects. He said that SWAYAM

MOOCS can also be implemented in the college.

- Dr. E. U. Masumdar expressed his opinion that Exam Section is the soul of autonomous colleges and the future of autonomous colleges depends upon the trustworthiness of the Exam system. He pointed out to the 50/50 pattern in Tamilnadu and suggested that Sangameshwar College can think of 40 /60 pattern. He objected to the 2 marks kept for attendance of students. Dr Masumdar appreciated the system of having separate passing for internal and external examinations, yet advised to have the system of combined passing, taking into consideration the problems in separate passing.

It was **resolved** that Examination pattern, Examination Cell, Paper Setters, Examiners, Moderators under Autonomy and the rules and regulations prepared by BOS regarding nature of question paper (except Accountancy), were unanimously sanctioned. It was unanimously decided that the 30% CA: 70% SEE exam pattern should be accepted. It was unanimously decided that the marks kept for attendance should be cancelled as majority of the members of the committee raised objections against it.

7. To approve for rules and regulation of evaluation System

The Chairman presented the proposal that the rules and regulations regarding Evaluation System prepared by the Board of Examination be approved. (ANNEXURE 12)

The topic was discussed in detail.

The university nominee Dr. G. S. Kamble suggested following:

1. An online evaluation system can be developed using Google Classroom.
2. No temporary staff should be appointed in the Examination Section.
3. It is mandatory to assign PRN number very systematically.
4. Dr Kirti Pandey asked to observe minutely if the change in the structure of the syllabi is reflected in the question paper and evaluation system.

It was **resolved** that the rules and regulations of Evaluation System prepared by the Board of Examination were unanimously approved.

8. Approval for admission procedure (UG and PG) and Admission for NSS, NCC,

The Chairman put forth the rules and regulations regarding Admissions for the academic year 2020-21 for approval. (ANNEXURE 13)

It was informed that the rules of the Government as well as the rules for Minority Institutes will be followed for the admissions for the academic year 2020-21. The Chairman also informed that a separate Entrance Exam will be conducted for BCA, BSc. (ECS), BBA and MSc (Computer Science). It was also pointed out that students having special proficiency in Sports and Cultural activities will be given preference. The aspirants of NSS, NCC will be admitted according to the guidelines provided for them.

It was *resolved* that the admission procedure for UG and PG, as per the rules of Government and Quota for NSS, NCC, Sports and Cultural aspirants duly to be considered in the academic year 2020-21, was unanimously approved with consensus.

9. To approve Statutory and Non-Statutory Committees

- Dr Masumdar pointed out that the topic cannot be included under the jurisdiction of Academic Council as it comes under the jurisdiction of Governing Body.
- The reports of NAAC, AQAR, NIRF, AISHF (for post facto sanction) can be presented in Academic Council.
- The topic of endowing Scholarships for students can also be included in Academic Council.

It was *resolved* that seeking approval for the statutory and non-statutory committees, comes under the jurisdiction of the Governing Body, the topic was unanimously cancelled.

10. Approval for 20% increase in student strength of B. Com.I, B.Sc. I, B.Sc. (ECS) I, BBA I, and BCA I class
